

Vanguard Superbowl LX Sweepstakes Official Rules

1. **Sponsor:** The Sponsor of the **Vanguard Superbowl LX Sweepstakes** (“Sweepstakes”) is Vanguard Music and Performing Arts, 1795 Space Park Drive, Santa Clara, CA 95054, a nonprofit public benefit corporation and 501(c)(3) tax-exempt charity duly registered with the California Department of Justice (“Sponsor”).
2. **Eligibility:** The Sweepstakes is open and offered only to legal residents of California, who are at least eighteen (18) years of age, who (1) purchase at least one Bingo package during the Sweepstakes Period (defined below); (2) are physically present at the Bingo event on the date of their purchase to receive their Sweepstakes entry (“Entrant”); and (3) have a valid California driver’s license or equivalent ID. Employees of Sponsor and their immediate families (parent, child, sibling, or spouse) and/or household members of respective parent companies, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies, and any other persons or entities associated with this promotion are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations, and is void outside the United States and where prohibited.
3. **Agreement to Official Rules:** By participating in the Sweepstakes, Entrant agrees to be fully and unconditionally bound by these official Sweepstakes rules (“Official Rules”), and Entrant represents and warrants that they meet the eligibility requirements. In addition, Entrant agrees to accept the decisions of Sponsor as final and binding as it relates to this Sweepstakes and consents to be contacted by Sponsor by email.
4. **Sweepstakes Period:** The Sweepstakes Period will commence on January 9, 2026 and end on January 31, 2026, at 11:59 PM PST. All qualifying Bingo package purchases must occur within the designated Sweepstakes Period to be eligible for entry. Limit: one Sweepstakes entry per Bingo Session per natural person.
5. **Bingo Session Locations, Dates, and Entry Hours:** All Bingo Sessions will take place at either the Santa Clara Bingo Hall (1795 Space Park Dr, Santa Clara, CA 95054) or the American Legion Hall in Redwood City (651 El Camino Real, Redwood City, CA 94063) at the following dates and times:

6. How to Enter: To enter the sweepstakes, Entrants may do one of the following:

- o Purchase online: Purchase any Bingo package online at scvanguard.org/bingo/ or scvanguard.org/bingo-rc/. One Sweepstakes entry will be provided per Session (purchasing multiple packages for one Bingo Session will not award additional entries).
- o Purchase at location: Purchase any Bingo package at the Bingo Location. Entrant may purchase a Bingo package at the Vanguard Bingo session and will be directed to complete a Sweepstakes entry.
- o No purchase necessary: To enter without making a purchase, Entrant may visit any Vanguard Bingo location during a Bingo Session. They will be directed to complete a Sweepstakes entry.

All Entrants will be required to provide their first and last name, address, telephone number, and email address. Entrant will receive a maximum one (1) Sweepstakes entry only for each Session, regardless of the size, price, or number of cards included in the Bingo package. Sweepstakes tickets will not be distributed by mail or electronically, and Bingo packages must be redeemed in person on the day of the session to qualify for the Sweepstakes. Entries must fulfill all Sweepstakes requirements, as specified in these Official Rules, to be eligible to win the Prize.

Please note that the Selected Winner (as defined below) may be required to be verified

in Person. Entries that do not adhere to these Official Rules may be disqualified at the sole discretion of Sponsor. No additional fee will be charged for participation in the Sweepstakes. No substitutions or transfers of Sweepstakes tickets or prizes are permitted. If Entrant uses fraudulent methods or otherwise attempts to circumvent the Official Rules, Entrant's submission may be removed from eligibility at the sole discretion of Sponsor. By entering, Entrant represents and warrants that all of the information provided as part of their entry is accurate, does not violate any third party's legal rights (including without limitation rights of privacy and publicity), and otherwise does not violate applicable law.

7. **Prize:** The selected winner of the Sweepstakes (the "Selected Winner") will be given the Prize, which is two (2) tickets to Superbowl LX to be held at Levi's Stadium in Santa Clara, CA on February 8, 2026 (the "Event"). **Tickets must be retrieved in person at the Santa Clara location listed in these rules, and Selected Winner must be a valid California ID.**
8. Any and all Prize-related expenses, including without limitation, transportation, parking and other incidentals or other costs incurred by acceptance of the Prize, shall be the sole responsibility of Selected Winner. No substitution of Prize or transfer/assignment of Prize to others or request for any special privilege by Selected Winner is permitted, except by Sponsor, who reserves the right to substitute the prize for something of equal or greater value for any reason. Acceptance of Prize constitutes permission for Sponsor to use Selected Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. Prize is awarded "AS IS" with no warranty, representation or guarantee, express or implied, in fact or in law, made by Sponsor or for which Sponsor shall be liable, including, without limitation, ANY IMPLIED WARRANTIES OF MERCHANTABILITY, NONINFRINGEMENT OR FITNESS FOR A PARTICULAR PURPOSE.
9. **Odds:** The odds of winning depend on the number of entries received.
10. **Selected Winner Selection and Notification:** At the conclusion of the Entry Period, on or about February 1, 2026, Sponsor will conduct a random drawing from among all eligible Sweepstakes tickets issued during the Sweepstakes Period. The selected winner will be notified in person or by contact information provided at the time of Bingo registration. The Selected Winner will be notified within forty-eight (48) hours following selection of the Selected Winner, by email or telephone number. Sponsor shall have no liability for the Selected Winner's failure to review messages or email notices from Sponsor due to SPAM filters, telephone block systems or other technology challenges or security settings or for the Selected Winner's provision of incorrect or otherwise non-functioning contact information. **THIS IS A TIME SENSITIVE EVENT. Selected Winner will have 48 hours to reply by email only.** If the Selected Winner cannot be contacted, is ineligible, or fails to claim the Prize within 96 hours, the Prize may be forfeited and an alternate Selected Winner may be selected by Sponsor, up to one time. Receipt by the Selected Winner of the Prize offered in this Sweepstakes is conditioned upon compliance with any and all federal, state, and local laws and regulations. ANY VIOLATION OF THESE

OFFICIAL RULES BY THE SELECTED WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN THE SELECTED WINNER'S DISQUALIFICATION AS SELECTED WINNER OF THE SWEEPSTAKES, AND ALL PRIVILEGES AS SELECTED WINNER WILL BE IMMEDIATELY TERMINATED.

11. Approximate Retail Value ("ARV"): \$20,000.
12. Prize Delivery: Selected Winner will receive an email containing details of when and where to collect the prize. Prize must be collected in person by Winner, and Winner must present all identification and eligibility documents described in Section 12 to collect the Prize.
13. Declaration of Eligibility: The Selected Winner will be required to execute and return to the Sponsor a declaration of eligibility (the "Declaration"), and Selected Winner must provide a valid California driver's license, in person, along with their winning ticket stub, to claim the prize. By completing, signing and returning the Declaration, the Selected Winner (i) releases and forever discharges the Sponsor, its affiliates and subsidiaries, and their respective advertising and promotional agencies from all claims, demands, damages, actions and causes of action arising out of participation in this Sweepstakes or to arise by use of the Prize, and (ii) confirms compliance with these Official Rules. If the Selected Winner is unable or unwilling to complete the Declaration in its entirety or is unable or unwilling to collect the Prize in person, Selected Winner forfeits the Prize.
14. Taxes: **THIS IS A TAXABLE EVENT.** Taxes are the sole responsibility of the winner. The Selected Winner will be required to complete a tax form W-9. Winner will receive an IRS form 1099 for the total ARV of the Prize as stated herein.
15. Terms & Conditions: All decisions of Sponsor regarding eligibility and winner selection are final and binding. Sponsor reserves the right to correct typographical errors that may result in unintended interpretations of these rules. Sponsor also reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes should a pandemic, public health emergency, computer virus or bug, non-authorized human intervention, fraud, or other cause beyond Sponsor's control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes. In such case, Sponsor may select the Selected Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Sweepstakes or violates these Official Rules. Sponsor has the right, in its sole discretion, to maintain the integrity of the Sweepstakes, to void entries for any reason. Any attempt by an individual to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil laws. Should such attempt be made, Sponsor reserves the right to seek damages to the fullest extent permitted by law. By entering, Entrants agree to comply with these Official Rules and all applicable laws and regulations.

16. Limitation of Liability: By entering, Entrant agrees to release and hold harmless Sponsor and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) Entrant's participation in the Sweepstakes and/or Entrant's acceptance, possession, use, or misuse of the Prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Sweepstakes; (v) electronic or human error in the administration of the Sweepstakes or the processing of entries; and (vi) participation in any Prize-related activity (including, without limitation, claims, costs, injuries, losses or damages related to personal injuries, death, damage to, loss or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light).
17. Disputes: THIS SWEEPSTAKES IS GOVERNED BY THE LAWS OF THE STATE OF CALIFORNIA, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in the Sweepstakes, Entrant agrees that the only remedy for dispute relating to this Sweepstakes is a Sweepstakes ticket. Any disputes relating to the receipt of the Prize that cannot be resolved between Entrant and the Sponsor, shall be resolved individually, without resort to any form of class action, exclusively before a court of competent jurisdiction located in Santa Clara County, CA. Further, in any such dispute, under no circumstances shall Entrant be permitted to obtain awards for, and Entrant hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than Entrant's actual out-of-pocket expenses (i.e., costs associated with entering this Sweepstakes). Entrant further waives all rights to have damages multiplied or increased.
18. Privacy Policy: Information submitted by Entrant in connection with the Sweepstakes is subject to the Privacy Policy stated on the Sponsor website. All personal information collected by Sponsor will be used for administration of the Sweepstakes. In addition, independent of the Privacy Policy, Entrants may receive email correspondence from, or on behalf of Sponsor. Sponsor uses reasonable commercial efforts to comply with Federal CAN-SPAM guidelines and to supply information to entities that comply with CAN-SPAM guidelines, and Entrants may subsequently opt-out of receiving further emails by following the opt-out instructions contained in the email. Any questions regarding privacy matters should be directed to the email address set out in Section 18 below.
